New Business

Inspector's Report

New crime alert has been issued for Lowry to Broadway and Riverfront to 5th St. (5 robbery pattern). May possibly have a connection with SE. Karla Nielsen transferred to downtown so direct questions to Nick. The juvenile program in Minneapolis has been used as a model nationwide.

Speaker: Andy Smith - Juvenile

Juvenile crime in 2nd is much lower than other parts of city. Last period we had 80% lower juvenile crime than rest of city. Most is currently centered around Central Ave & Jackson Park. The inspector has built a program to address this. A multiple stakeholder-involvement (City Departments, Park, Edison, YMCA, etc.) has been key to addressing these issues. Since March there has been a downtown increase in juvenile crime. Nicollet Ave. activities are new to those vibrant businesses. There is real-time communication with security guards, and cameras have been very helpful. Nine juveniles have been arrested related to recent activity. Observation by undercover cops has been a useful tool in fighting this as well.

Juvenile crime get a lot of press, but mainly adults do most crime (roughly 15% of eastside crime could be juvenile). Most juvenile crime is property offences. Violent crime gets police/media attention. Age range is mostly 14-17. Some juvenile violent crimes have seen jump, but not in 2nd precinct (other areas of city). Marijuanna is common, but other drugs have gone down. Gang crime is seen in 2nd, but some of that comes from school, Columbia Heights, and some western suburbs. Violent gang crime is not common in 2nd Precinct. Some gangs have evolved out of the tagging problem, but lots of tagging is unrelated to gangs.

The juvenile system, as it is, is set up to focus on getting kids on the right path. The adult system is really about getting felons behind bars. We have a strong program JDAI (Juvenile Detention Alternatives Initiative) here (housing kids in facility does more harm than good), so courts try hard to get kids in the system into a rehabilitative process. Courts attempt to include families in this process as well. Kids with guns/weapons have community service requirement. If not completed, may be sent to out-of-home placement. The last desire is lock the child up. The system doesn't hold parents accountable as it is.

There is a definite lack of youth programs in current years. Businesses often don't get involved sometimes because of liability. Probation doesn't have the time to solicit businesses to help. Businesses have, however, contributed money for some programs.

Juvenile probation officers commonly have a 20-45 kid caseload. Old caseload had an average high of 50 juveniles. Some juveniles will have adult prison time hanging over them while on probation to age 21.
