New/Old Business

2PAC board members met with councilmember Reich last week (Friday, Feb. 10th). Activities for youth were discussed that could benefit neighborhoods and reduce crime.

State of the Precinct Inspector Report

2012 should see an upgrade to the 2nd precinct building. Updating this to a modern facility is a 2012 goal.

Citywide Part 1 crime up 4% Violent crime down 6%

2nd Precinct Part 1 up 2% Violent crime down 13%

Property crime up 4%

Question responses

Overtime savings - 2nd precinct is a leader in overtime and idling reduction. We can hope that some money will come to the 2nd precinct from the earned savings.

Increase in robberies in U area and upcoming Ritz area – Fri and Sat patrol remedied the increase. Initially, customers leaving the bar/restaurant who were unaware of surroundings, with headphones, walking alone, etc. were being robbed.

Crime opportunity information does not appear to be networked – the police see the same faces committing these crimes.

Police are addressing youth issues before they get going. Police are considering a number of options – using beat patrols, talking with the parks to get programming, lowering riverfront crime contribution with patrols and engagement, partnership with the U of M, using hotspot predictive analysis, creating a surgical focus to upcoming crime enforcement.
