Business

Child Protection (Pam Orren CP intake)

7-3:30 pm every day 24/7 organization 8am-11pm can be a common shift.

Reasons for Reporting

- Physical abuse - non-accidental injury inflicted by parent or legal caregiver Injuries you can see on kids.
- Any sexual contact with minor. Any person convicted level 3 cannot have contact with child and may not visit house with kids without investigation
- Neglect- fail to provide for necessary needs, fail to protect from endangerment.
- Child abandonment – leaves child and has no contact for 6 month for child under 2.
- Chronic use of drugs/alcohol by parent.
- For prenatal exposure to illegal substances you can also call and report

Supervision –

Parents need to provide age appropriate supervision for kids around traffic, water, etc. Kids alone: no one under 7 years should ever be left alone. CP looks at age maturity, accessibility of parent by phone, location, or alternate adult. Check to see if they are expected to use stoves, irons, etc.

Age	Time allowed alone
8-10	three hours
11- 13	up to 12 hrs
14, 15	up to 24 hrs
16, 17	indefinite if basic needs are met

Children can't babysit until age 11. The number they can babysit is also limited.

Process

How the process begins is with a call to a CP intake worker expressing concern with child in neighborhood. It can be anonymous, but by leaving your name you can check on progress.

Traditional investigation harm to child and all sex abuse. Always contact police to see if they want to interview. First kids then talk to the parent. If in imminent danger, they can take kids to center, they do thorough investigation. CP must be in court within 72 hrs with petition of why the kids need to be protected. The court will make a determination if the protection will expire or not. Family may get case worker as kids return.

People can refuse to let child protection in. CP can interview kids in school and day care.

Family assessments meet with family as a group. Worker will ask for the story from the parent perspective. What can be done so that there is no family danger when they leave the assessment? CP can offer services, but there is no obligation for the family to accept.

Educational neglect

Not registered from ages 7-18 and not enrolled in school. Kids aged 16-17 must have been withdrawn by parents. Homeschooled kids must have intent to homeschool paperwork submitted. Ages 5-11 are defined as educational neglect and 12-18 truancy. Reports must come from the school. CP doesn't open cases unless severe.

Other Information and Resources

Transient bruises (slap) that will disappear do not lead to investigation report.

Sibling injuries can lead to lack of supervision report. Bruise from reasonable restrain – no report.

Parent drinking and driving – must call police to check the driver. Need the precise measurement tool to get the endangerment charge.

Wakanheza (child within, sacred being) training– teach strategies to handle parenting in public situations
